The annual revenue generated by my business, coupled with my personal savings, provides me with the necessary financial resources to cover all travel expenses, including accommodation, meals, and any unforeseen circumstances that may arise.

## Family ties in Bangladesh

Despite the allure of staying in Canada, I am committed to returning to my home country, after the conclusion of my trip. I have significant family ties and responsibilities in my country, including the care of my old mother, Obaida Khatoon (59), and my younger brother who is still completing his studies. It is my moral duty to attend to their needs and fulfill my responsibilities towards them.
